- These findings have already been delivered directly to multiple executive departments, including the Department of Government Efficiency (DOGE), as well as to Congress in 40 states, the U.S. Congress, and over 600 other departments, agencies, and public servants' offices across the country over the last six years.
- We are actively working with DOGE through multiple visits, ongoing dialogue, and future meetings underway—to ensure the People's grievances are addressed and the record corrected in lawful alignment.
