Kirk joined the Delayed Entry Program of the Marine Corps in 1990, joined Job Corps until he left for Bootcamp at Camp Pendleton, followed by Marine Combat Training, Schools Battalion at Camp Delmar for training as a Unit Diary Clerk (MOS 0131), and then Stationed as a Reservist at 4th Marine Tanker Battalion based in Boise, Idaho. Kirk’s Unit was deployed to Iraq for Desert Storm/Desert Shield while he was still in training and received his National Defense Ribbon for being “active duty/in service” during time of war.

Kirk has many skills from Auto Mechanic, to woodworking, Finish Carpentry, and has learned many of the Construction Trades over the years, including an Electrician in 2007. Kirk is also a Certified A+ hardware/Software Technician and Network+ Technician. Kirk has had training in Advanced Server operations as well.

In January of 2026 Kirk started working with Toll and Roll™ as a Delegate and Relator for We the People and continuing the work he and Chris Hallet began in 2017 with E-Clause LLC.
