

# **A BILL**

## **National Recovery Fund and Restitution Act**

To establish the People's Remedy and Restoration National Recovery Fund, to require Treasury trust management, to set lawful distribution priorities, and to mandate public reporting.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

### **SEC. 1. SHORT TITLE.**

This Act may be cited as the "National Recovery Fund and Restitution Act."

### **SEC. 2. FEDERAL PROCEEDS; DEPOSIT INTO FUND; PROHIBITION ON DIVERSION.**

(a) Federal proceeds. All amounts recovered under this Act, including fines, penalties, fees, forfeitures, treble damages, settlements, and any other monetary recoveries, are hereby declared to be Federal proceeds.

(b) Deposit. The Secretary of the Treasury shall deposit all Federal proceeds described in subsection (a) into the National Recovery Fund established under this Act, to be held in trust for the People and to be administered in accordance with this Act.

(c) Prohibition on diversion. Notwithstanding any other provision of law, Federal proceeds described in subsection (a) shall not be retained by, transferred to, or distributed to any State, political subdivision of a State, or any private or foreign person or entity, except as expressly provided in this Act.

(d) Rule of construction. Nothing in this section shall be construed to limit the authority of a court to order restitution to victims, or to otherwise affect any distribution required under this Act.

### **SEC. 3. IDENTIFICATION, SEIZURE, AND TRANSFER.**

(a) DOGE shall identify and audit assets connected to fraudulent instruments, counterfeit filings, or unlawful systems.

(b) Upon verification, DOGE shall issue a federal seizure order under the National Emergencies Act, directing federal enforcement agencies to secure such assets.

(c) The United States Marshals Service, coordinated with the DOJ and other necessary agencies, shall physically and digitally execute seizures, including bank accounts and trusts, real property and estates, digital platforms and servers, and evidence of fraud or trafficking concealed within land and court record systems.

- (d) Seizures shall be conducted in the presence of an appointed representative from the Office of P.R.O.T.E.C.T.
- (e) Upon seizure, DOGE shall transfer monetary assets and liquidated property into the People's Remedy and Restoration National Recovery Fund, managed exclusively by the United States Treasury, held in trust for the People, with transparent records and independent auditing.

#### **SEC. 4. GOVERNING BOARD.**

- (a) A Governing Board shall oversee the Fund and distributions to ensure accountability and to prevent conflicts of interest.
- (b) The Board shall consist of the Framers of the national remedy framework, representing the People and the Petition of Remonstrance, and one independent appointee approved by Congress, with strict conflict screening.
- (c) The Board shall approve the Distribution Manager, certify reporting, and authorize major disbursements.

#### **SEC. 5. DISTRIBUTION MANAGER.**

- (a) DOGE shall appoint a Distribution Manager, subject to Board approval, with no ties to implicated entities, and barred from future employment with organizations involved in the addressed fraud and trafficking.
- (b) Any violation of these standards results in immediate termination and federal prosecution.

#### **SEC. 6. DISTRIBUTION PRIORITIES.**

Treasury shall disburse funds in the following priority order:

- (1) treble damages and direct restitution to victims, including return of stolen property and restoration of family rights,
- (2) replenishment of retirement systems for lawful, non complicit public servants,
- (3) reduction of the national debt,
- (4) equitable per capita distribution to natural born American citizens.

#### **SEC. 7. TRANSPARENCY AND REPORTING.**

- (a) Treasury shall establish an Office of Recovery and Restitution Reporting, publishing quarterly public reports with aggregated data, protecting victim identity.
- (b) Reports shall be verified by DOGE and P.R.O.T.E.C.T. prior to release.

#### **SEC. 8. NATIONAL EMERGENCY FINDING AND AUTHORIZATION.**

- (a) Congress finds that systemic corruption, manipulation, and obstruction within land record systems, court record systems, and associated judicial processes threatens public integrity, constitutional governance, and national security.

(b) Implementation and enforcement of this Act shall be treated as addressing a national emergency affecting the security of the United States, and all available authorities for critical infrastructure protection and emergency response shall be used promptly, consistent with applicable law.

(c) The Office of P.R.O.T.E.C.T. shall coordinate with Congress, executive agencies, and law enforcement to ensure that findings and certified records are preserved, protected, and acted upon without delay, and to prevent concealment or destruction of evidence.

## **SEC. 9. DOMESTIC TERRORISM, REFERRAL, AND AGGRAVATED VIOLATIONS.**

(a) Domestic Violence referral. Any person who knowingly and willfully violates this Act, or conspires to violate this Act, in a manner that meets the definition of domestic Violence under section 2331(5) of title 18, United States Code, shall be treated as engaging in domestic Violence for purposes of investigation and prosecution, and shall be referred by DOGE to the Department of Justice and appropriate Federal agencies for enforcement under applicable law.

(b) Pattern and enterprise conduct. Where violations of this Act are committed as part of an enterprise, network, or coordinated scheme involving record manipulation, trafficking indicators, concealment, or systematic deprivation of rights under color of law, DOGE shall prioritize expedited referral for racketeering, civil rights, and other applicable Federal charges.

(c) No safe harbor. No contract clause, vendor term, court custom, or administrative policy may be asserted as a defense to a violation of this Act, or to conduct referred under subsection (a) or (b).

## **SEC. 10. NATIONAL EMERGENCY, NATIONAL SECURITY, AND DEPARTMENT OF DEFENSE INVOLVEMENT.**

(a) **Finding of national security threat.** Congress finds that systemic compromise of land records, court records, and connected record platforms constitutes a threat to national security and critical infrastructure, enabling large scale fraud, coercion under color of law, and foreign and domestic intrusion.

(b) **National emergency designation.** Congress declares that implementation and enforcement of this Act addresses a national emergency affecting the security of the United States, and directs that all available emergency and critical infrastructure protection authorities be promptly used, consistent with the National Emergencies Act and other applicable law.

(c) **Department of Defense required role, defensive support only.** This Act constitutes express Congressional authorization for the Department of Defense to provide Defense Support of Civil Authorities for the limited purposes of defensive cyber support, incident response, technical assistance, communications, logistics, and forensic preservation of evidence needed to secure covered record systems and prevent further compromise. Such

support shall be coordinated with the lead federal agency designated in this Act and shall not include direct participation in civilian law enforcement activities except where expressly authorized by Act of Congress, consistent with 18 U.S.C. § 1385.

**(d) Mandatory referral for domestic Violence and treason where legally applicable.** Any person who knowingly compromises covered systems, destroys audit logs, obstructs audits, or provides material assistance to foreign or domestic actors to manipulate records or to seize property or persons under false authority shall be referred to the Attorney General for investigation and prosecution under applicable federal law, including domestic Violence related offenses where supported by evidence, and treason only where the constitutional elements of Article III, Section 3 are satisfied.
